Memorandum of Cooperation (MOC)

UNIVERSITY of ISFAHAN (I. R. IRAN)

And

# AL-FARABI ACADEMIC ASSOCIATION - AL-FARABI INSTITUTE FOR HIGH STUDIES (R. IRAQ)

According to the M.O.U. signed between University of Isfahan and Al-Farabi International Group for Knowledge and Development in the University of Isfahan on Monday 28<sup>th</sup> November 2014, and due to their mutual desire to put a roadmap for performing this cooperation, University of Isfahan (UI) and Al-Farabi Institute for High Studies (AFIHS) agreed and accepted all of the following items:

- 1 (a) UI registers the students who finished their studies successfully for the requirements of the preliminary year at AFIHS with their personal documents (including, B.Sc. degree) endorsed by the Foreign Ministry of R. Iraq. The subjects of courses that students attended in their first year should coincide with the specialties and academic levels at UI. The Admission committee of UI will assess the exams results of students during the first year and decide on admitting students. The committee may request students to attend more required courses if they need as an additional semester prior to their second year of study at UI.
- (b) UI provides the research programs and laboratories and materials needed to execute the research (if required) to the students.
- (c) UI provides logistic requirements (student dormitories) at its premises. The students should pay a nominal charge of 180 US \$ per month for the current academic year through the periods required to finish the research (if possible). This fee will have an annual increase rate of 20%.

- (d) UI provides research requirements for science and engineering students in English Language. The thesis will be submitted in English Language and the discussions of final examination committee will be also in English Language, while it will be preferably in Arabic Language for humanities.
- (e) UI determines supervisors for the students according to their desires and the need of the society. The supervision could be performed jointly by UI and AFIHS or only by UI.
- (f) UI issues final enrollment documents for the students upon their admission to finish their preliminary requirements, in order to get academic leave from their offices and to be registered at the Office of Scholarships at the Ministry of Higher Education in R. Iraq.
- 2. (a) AFIHS sends the particulars and documents of the students to be enrolled at UI certified from the Foreign Ministry of R. Iraq and their results of the final exams of the first year.
- (b) AFIHS provides the subjects of the courses given to the students, for each department in two semesters.
- (c) AFIHS pays the tuition fees with the sum of 4500 US \$ per year for science and engineering (6750 US \$ for three semesters if additional semester is required) and 3500 US \$ for humanities (5250 US \$ for three semesters if additional semester is required) per each student in two parts for the current academic year; the first at students admission and the second at the beginning of writing their theses. These sums include supervision examination committee and graduation affairs and will have an annual increase rate of 15%.
- 3. The residence of the students in I.R. Iran will be at least 9 months according to the requirements of the Foreign Ministry of R. Iraq.
- 4. AFIHS has the right to send its students to the UI for the total periods of the above mentioned degrees according to its regulations.
- 5. Students may finish all requirements regarding their first year courses in AFIHS according to the programs of the UI, except the final examination which will be held in the UI. Students will receive their documents from UI after they pay all the costs to the UI.
- 6. This MOC shall remain valid for five years and shall be automatically extended for a similar term, unless any party notifies the other, six months in advance, its written intention to terminate it.
- 7. This MOC has been signed on 1393/10/14 (Solar year) corresponding to 04/01/2015 (Christian year) in 2 copies both of which are equally authentic and shall come into force upon the signature of both parties.
