



## MEMORANDUM OF UNDERSTANDING BETWEEN UNIVERSITY OF ZAGREB (CROATIA) AND UNIVERSITY OF ISFAHAN (I.R. IRAN)

The University of Zagreb, Zagreb, Trg Republike Hrvatske 14 and University of Isfahan, Isfahan, I.R. Iran, have agreed to enter into this Memorandum of Understanding (MOU) to enhance relations between the two universities; to develop academic and cultural interchange in the areas of education, research, and other activities; and to cooperate toward the internationalization of higher education.

The areas of cooperation will include any program offered at either university which is felt to be desirable and feasible for the development and strengthening of cooperative relationships between the two institutions. However, any specific program shall be subject to mutual consent, availability of funds, and approval of each university. Such programs may include:

- Exchange of faculty members
- Exchange of students
- Joint research projects
- Joint conferences
- Promotion of joint academic activities such as seminars and conferences
- Joint cultural programs
- Exchange of publication and other academic material
- Other forms of university co-operation of mutual interest

The terms of such mutual assistance and cooperation shall be discussed and agreed upon in writing by the appropriate responsible authority of each university prior to the initiation of any particular program or activity and must be contained in subsequent specific agreements. It is also understood that any financial arrangements will be negotiated and agreed to in writing for each specific case and will depend upon availability of funds.

Exchange of faculty members and exchange of students will be regulated by the special agreement and/or the working programme between the institutions.

The universities stated that the medical and accident insurance expenses during the stay of any exchange staff or student will be covered by the respective staff or student participating in the exchange programme.

This MOU shall remain in force for a period of five years from the date of the last signature, with the understanding that either party giving six months prior notice to the other party in writing may terminate it. The MOU may be extended by mutual consent of the two parties and its terms may be varied at the time of any renewal. The parties shall sign two (2) originals of this MOU. Each party shall retain one original.





All notices required hereunder shall be in writing and delivered by a duly authorized representative of the Party giving the notice and sent by email transmission to the following addresses. Either Party may change its email address for notice purposes by providing prior written notice to the other party. Any notice sent by email shall be deemed to have been delivered at the time of confirmation of receipt by the addressee.
